On this date at approximately 0715 hrs, members of the North Kingstown Police Department executed a search warrant for the address of 57 Grove Avenue, North Kingstown, RI. Also included with that search warrant was an Arrest Warrant for Maureen Rondeau (DOB 06/22/1969) for the charge of Embezzlement and Fraudulent Conversion. Present for the execution of the warrants were Det. Lt. Emerson, Det. Sgt. St. Onge, Det. Hazard, Det. Dennison, P/O Silva and I.

On arrival to the residence, we knocked on the entrances and announced ourselves. It took over five minutes for someone to respond to our knocks. During that time, we observed that there were cameras monitoring all of the entrances to the residence. When someone did respond, a subject identified himself as Jeffrey Rondeau (owner/resident). We advised Mr. Rondeau that we had a search warrant for the premises to include several vehicles located on the property. Mr. Rondeau acknowledged our presence and we made entry into the residence. Once inside, we asked if his wife Maureen Rondeau was present. Mr. Rondeau stated she was in the bedroom upstairs. Mrs. Rondeau came downstairs after having to be ordered downstairs. Once in the living room, I positively identified her by her name, date of birth and picture. I advised Mrs. Rondeau that I had a warrant for her arrest for the charge of embezzlement. She was issued her Miranda Warning.

After being issued her Miranda Warning, Mrs. Rondeau was asked if she knew what this was about. Mrs. Rondeau would not reply. At this point, she was allowed to change and taken into custody. P/O Michelle Kinney and P/O Silva then transported Mrs. Rondeau to headquarters where she was made cell safe in secured in cell #28.

Mr. Rondeau was issued his copy of the search warrant. Mr. Rondeau wished to remain in the residence under the supervision of Det. Lt. Emerson. Det. Sgt. St. Onge, Det. Hazard, Det. Denniston and I began the execution of the search warrant. Det. Sgt. St. Onge and I conducted the search while Det. Hazard and Det. Denniston photographed and logged all found evidence.
